

## Guide to Completing the IMM5709 (10-2015) E Form Study Permit Restoration

<p>7. a) Have you ever remained beyond the validity of your status, attended school without authorization or worked without authorization in Canada? b) Have you ever refused any kind of visa, admission, or been ordered to leave Canada or any other country?  c) Have you previously applied to enter or remain in Canada?</p>	<p>If you have studied or worked without a valid study or work permit, you will need to provide details and explanation. You will need to explain why you did not renew your status before the expiry date.  If you were ever refused any visa, admission to Canada or any other country please indicate and briefly explain.  Yes. List all visa/ permits previously applied for and when i.e. study permit renewal, or co-op work permit or Temporary resident visa-Sept 2013.</p>
