If you have studied or worked without a valid study or work permit, you will need to provide details and explanation. If you were ever refused any visa, admission to Canada or any other country please indicate and briefly explain. Yes. List all visa/ permits previously applied for and when i.e. Temporary resident visa-Sept 2013 or Visitor Record.
