Items under faculty control

<p>Seek information on how AI tools are working and on their limitations.</p> <p>Discuss with colleagues to establish a consensus at the disciplinary level.</p> <p>Be curious about AI tools enough to establish a basic competency in prompt writing.</p> <p>Integrate ethics as part of learning technical skills to use AI-driven tools.</p>	<p>Even if you do not have all the answers, express clearly in your syllabus what you consider to be acceptable use.</p> <p>Articulate to students the rationale for limitations on acceptable use.</p> <p>Invite students to participate in a discussion to help you refine your views.</p> <p>Assume that most of your students are seeking to learn, not commit offences.</p>	<p>Distinguish between producing work using AI tools and summative assessment of university-level education.</p> <p>Determine whether you can assess evidence of work instead of exclusively final deliverables.</p> <p>Define a way for students to acknowledge the use of tools.</p> <p>Explore the use of AI tools as an adaptative or assistive strategy to enhance your ability to support learning.</p>	<p>Be prepared for many more disruptions affecting the way we interact with information and knowledge.</p> <p>Do not assume that all students have equitable access to AI tools.</p> <p>Engage in discussion on the future of your discipline and how it may affect program outcomes.</p>

Three general approaches to consider for a course syllabus.

	Acceptable use for learning and assessment?	Acceptable use for learning only	Restricted use
	<i>Students are expected to be accountable for the work that they produce and acknowledge tools used to produce the work to be assessed</i>	<i>Students are allowed to use chatbots for learning and for producing <u>formative</u> assessment work. They are, however, expected to be able to produce work of equivalent academic value without these tools.</i>	<i>There should be a strong academic rationale for this position. Ideally, a temporary approach until another model may be adopted.</i>
Syllabus statement	<p>Feel free to use AI-driven tool to assist you in learning but remember that the objective is for you to acquire these competencies and outcomes in this course.</p> <p>You are responsible for all work that you produce, whether assisted by an AI-driven tool or not. You must acknowledge all tools used to assist you. If applicable, you must provide links to chat logs.</p> <p>If the work that you produce is suspected to misrepresent your own competencies, you may be asked to complete a supplemental assessment to evaluate your mastery of course outcomes.</p>	<p>Feel free to use AI-driven tools to assist you in learning but remember that the objective is for you to acquire the competencies and outcomes in this course.</p> <p>While you may use tools for learning, specific assessments in this course will disallow the use of AI-driven tools to assert that you have attained course learning outcomes. This is because a graduate must be able to analyse, assess and produce work unassisted by AI technology.</p> <p>Where tools are allowed: you must acknowledge all tools used to assist you. If applicable, you must provide links to chat logs.</p> <p>Using AI-driven tools where prohibited constitutes an academic offense.</p>	<p>Feel free to use AI-driven tools to assist your learning, but you may not use them at all to produce work to be submitted for either formative or summative evaluations.</p> <p>Due to the nature of this course, it would be impractical and more difficult for everyone to assess students properly if AI tools were allowed. For this reason, and even if these tools will be a valuable tool in your career, their use is restricted so that your learning may be assessed.</p> <p>Using AI-driven tools to support the production of submitted work constitutes an academic offence.</p>
Suggested grading scheme	<p>Option 1 – Unchanged</p> <p>Option 2 – A small fraction of students selected randomly are assessed using a supplemental assessment.</p>	<p>Many instances of formative activities, with a few summative assessments where the use of tools is explicitly prohibited.</p> <p>Require proof-of-work as part of summative assessments.</p> <p>Formative marks may be unlocked by obtaining a pass grade on summative assessment.</p>	<p>Assessments should be designed to inhibit the use of AI-driven tools.</p>
What constitutes an academic integrity offense	<p>Under this model, a student unable to demonstrate an understanding of their own work is considered to have earned a failing grade, not committed an academic offense.</p>	<p>Use of tools to assist where clearly indicated that they are disallowed constitutes an academic offence. The allegation may not mainly rest on AI-driven detection of AI-generated work.</p>	<p>Any evidence of AI-driven tool <u>use</u> may be added to an allegation of plagiarism. However, using an AI tool to assess whether work was generated by AI should not be considered as credible.</p>
