



EXPLORE - English Immersion Consent Form

Parent / Guardian and participants, please read carefully the following terms and conditions regarding participation in the program :

I have read, understood and agree to the following :

- 1 The use of English is mandatory at all times.
- 2 The program may include participation in physical sports and activities, including but not limited to volleyball, swimming, water polo and horseback riding. I understand, appreciate and accept the risk of physical injury while participating in the program activities.
- 3 Dalhousie University reserves the right to assign a participant to a group most appropriate to his/her abilities and skill level and to require any participant to withdraw from the EXPLORE program if the participant is not acting in an appropriate and responsible manner.
- 4 Punctual attendance is required for all classes, workshops and other mandatory activities.
- 5 Dalhousie is not responsible for damage or loss of property owned by the participant. The participant agrees to indemnify Dalhousie for any such loss or damage.
- 6 All participants must observe the rules of the residence facilities of Dalhousie University. If the participant does not follow these rules, they may be asked to leave the EXPLORE Program immediately. - 7 The participant is responsible for any damage to or the loss of property belonging to Dalhousie University caused by the participant.
- 8 I understand that the bursary covers tuition and learning materials (but not pens, notebooks, dictionaries, etc.); obligatory excursions and some optional activities; room and board, including 3 meals each day. I understand I am responsible for all expenses not covered by the bursary including but not limited to pocket money, the non-refundable registration deposit of \$275 along with the \$100 refundable damage deposit and the cost of transportation to and from Halifax.
- 9 I understand that the events of the EXPLORE English Immersion Program may be videotaped, photographed, and/or displayed on the Dalhousie University website and used for Dalhousie University promotional, marketing and/or educational purposes. I consent to being photographed and/or videotaped for these purposes.
- 10 If dismissed from the program for any reason, the participant is required to make alternative travel arrangement and leave the premises within 24hrs. You will be provided with food and lodging until your departure.
- 11 If dismissed from the program for any reason regardless of the date, the participant will not receive a certificate of completion and/or graduation letter from EXPLORE.
- 12 I have read and understand all of the policies and procedures as outlined in the EXPLORE Handbook.



For participants under the age of 19, the parent / guardian understands and agrees as follows:

- 1 I consent to a member of the staff of the EXPLORE English Immersion Program to seek medical attention for my child if necessary. I understand that I will be informed by EXPLORE staff as soon as reasonably possible of any medical problem concerning my child for which treatment must be sought.
- 2 I understand that the events of the EXPLORE English Immersion Program may be videotaped, photographed, and/or displayed on the Dalhousie University website and used for Dalhousie University promotional, marketing and/or educational purposes. I consent to my child being photographed and/or videotaped for these purposes.
- 3 If your child is dismissed from the program for any reason, you will be contacted by EXPLORE staff at the time of the dismissal and you will also have the opportunity to speak with your child at that time. They will be provided with food and unsupervised accommodations until their departure. It is your responsibility to make alternative travel arrangements for your child as soon as possible and you will be responsible for any additional expenses that may be incurred due to the change in travel plans.
