

# DASA Positions on Academic Committees (Fall 2023)

**Responsibilities:**

Student representatives are full voting members of all academic committees in the Faculty and the School. As dual representatives of both DASA and these committees, they are responsible for reporting committee items to DASA, reporting DASA items to the committees, and participating in committee discussions and decisions.

**Procedure:**

At the beginning of each term the DASA presidents send a list of student reps to the Architecture office. This list is posted on the School's DASA web page and distributed to the chairs of the committees so that student reps can receive meeting notices and agendas. To avoid conflicts with classes, most meetings are scheduled during the weekly time slot reserved for faculty meetings.
