A report was provided by the Equity and Inclusion Committee.

Document was provided without track changes; suggestion was made that Faculty Council should see what the changes are. Faculty Council voted as to whether or not to accept the recommendation or ask the committee to submit the document with the changes highlighted. Terry Lewis, Chair of the Equity and Inclusion Committee, provided a background as to why changes were made and what the changes were.

Suggestions:

Under "functions": include research to make it more fulsome around all the work done. This was expanded on by another person, suggesting that research should be on an equal footing with teaching within the committee's function, including building institutional support for researchers, whose work is vulnerable in the areas of EDIA because of the way it is taken up and used.

There was concern expressed that the suggestions may be putting more on the committee than it was intended to bear; perhaps some of this needs to be held in another place?

Terry will take the suggestions back to the working group and the Equity and Inclusion Committee. It was cautioned that extensive changes don't need to be made, it needs to be a nimble document.
