## AWARD CRITERIA

### **Alumnus/a of the Year**

This has been awarded annually since 1958 to recognize the unique and major contributions made by a retired or still active physician to clinical practice, teaching, and/or research at a national level. International recognition, publications, and participation in national professional and academic societies constitute an expected profile for nominees of this award.

### **Honorary President**

This award was introduced in 1958 at the inaugural DMAA meeting. Priority is given to nominees who are senior local alumni, or past or present members of the Faculty of Medicine, who are highly respected, and whose careers and service in the practice of medicine have been outstanding. This does not exclude consideration, if warranted, of non-local, non-faculty nominees.

### **Family Physician of the Year**

This award, introduced in 2007, recognizes the contributions to medical practice and communities by family physicians. The impact of the lifetime work of physicians who practice in small and rural communities is often not acknowledged. The DMAA wishes to honour a family physician who exemplifies good medical care and is a role model in the practice of family medicine, a teacher of undergraduate medical students and residents, and an advocate for the health of his/her community. Alumni who practice in the Maritime Provinces are the focus of this award; however, non-local nominees will be considered.

### **Young Alumnus/a of the Year**

Instituted in 2002, this award recognizes a Dalhousie Medical School graduate in the first two decades of his/her career that has made a significant contribution to Dalhousie Medical School, other medical schools, or their community. This contribution can be in clinical practice, teaching, research, or public service.

### **Resident Leadership Award – Family Medicine (including Enhanced Skills Programs)**

Instituted in 2020, this award recognizes a Dalhousie Medical School resident in a Family Medicine or Family Medicine Enhanced Skills program who has demonstrated outstanding leadership. Areas of leadership could include but are not limited to advocacy, research, community engagement, mentorship of students and/or other residents, or administration. Nominees must be in a residency program at time of nomination to be eligible.

### **Resident Leadership Award – Royal College Specialties and Subspecialties**

Instituted in 2020, this award recognizes a Dalhousie Medical School resident in a Royal College Specialty or Subspecialty program who has demonstrated outstanding leadership in their field. Areas of leadership could include but are not limited to advocacy, research, community engagement, mentorship of students and/or other residents, or administration. Nominees must be in a residency program at time of nomination to be eligible.

The Faculty of Medicine strives to reflect the diversity in our own community and is committed to the principles of meritocracy and equity, taking action to support the access and success of under-represented groups such as: women; Indigenous Peoples, with emphasis on Mi'kmaq peoples; Persons with Disabilities; racialized persons (visible minorities), with an emphasis on African Nova Scotians and African Canadians; and persons who traditionally have not had the opportunity for university education because of economic, social and cultural reasons, lack of formal education or residence in non-urban areas.
