Sharon Batt is an independent scholar and an adjunct professor in the Department of Bioethics at Dalhousie University. She is an affiliate adjunct professor at Georgetown University in Washington, D.C. and a research fellow at PharmedOut, a project to advance evidence-based prescribing based at Georgetown University's Medical Center. She collaborates with researchers at Common Sense Oncology, based at Queen's University. Her work in pharmaceutical policy and health politics integrates scholarly research, public education, and social change activism. Her latest book, *Health Advocacy Inc.: How Pharmaceutical Funding Changed the Breast Cancer Movement* (UBC Press, 2017) is an insider analysis of the alliances between patient groups and the pharmaceutical industry and the implications for health policy, social fairness, and democracy.

She is currently a co-investigator on a research project to study disparities in access to precision oncology drugs across Canada, led by oncologists at Queen's University and funded by the Terry Fox Research Institute. Projects with PharmedOut include the 2024 book-length report, *What Needs to Change at the FDA? Protecting and Advancing Public Health*, funded by Arnold Ventures. Recent publications include a comment on Canada's lack of transparency in pharmaceutical donations for *Healthcare Policy*, a co-authored opinion on overall survival as the relevant endpoint for cancer trials, and an investigative journalism article on patient advocacy group leaders and their ties to the pharmaceutical industry.

At Dalhousie, she contributes to regular meetings in the Department of Bioethics, has served on a committee to revise ethics standards for the Faculty of Medicine, has participated in an annual class on advocacy for students in the Faculty of Medicine, and has served on thesis and dissertation committees in the Department of Political Science. Academic exchanges/collaborations include visits to PharmedOut at Georgetown University, the Mario Negri Institute in Milan, and Concordia University in Montreal; guest presentations in a course on Global Oncology and Cancer Policy at Queen's University and a course on Pharmaceutical Regulation at Osgoode Hall Law School. Public and community engagement includes participation in national consultations on mammography screening, on regulations to control the price of patented medicines in Canada, and with the community organizations Independent Voices for Safe and Effective Drugs, and the Nova Scotia Health Coalition.
