## **Course Description**

This course explains the importance of plants and their role in human biological and cultural development. It gives an opportunity for students to learn the impact of plants on society for their use as a major food source, as medicine, and in the industrial and recreational world. Additionally, it explains the role of plants in ecosystem conservation and sustainability. Students will involve in hands-on field activities and seminars to investigate plants on the aspect of their uses and interactions.

#### **General Policies:**
