Course Description

A field-based immersion into environmental field sampling methods. Students gain skills in flora and fauna identification and inventory, assessment of ecosystem health, and sampling methods for air and soil. GPS, GIS, and basic remote sensing skills are utilized in sampling design, collection and visualization of results.

Course Materials

- Students are expected to check Brightspace regularly for announcements and files.
- There is no textbook for this course. Field guides, binoculars, and digital resources will be provided.
- Students must have a field notebook. An all-weather notebook (e.g., Rite in the Rain) is an option and may be available for purchase at the Dal Bookstore. Students can choose a used notebook if there are enough empty pages (minimum 24). Sketching will be required during the course so a notebook without lines is recommended if a student prefers drawing on blank pages.
- A smart phone is required as we will use free mobile apps such as Merlin (Cornell Lab), Cram (digital flash cards), and iNaturalist. All apps are free and available on multiple platforms (e.g., iOS, android).
- Students are expected to have appropriate outerwear for comfortably conducting field work in variable weather conditions.

Field Excursions

- There are several on and off-campus field excursions that are the core of this course. They enable students to develop field skills, build outdoor competencies, collect data, and have fun!
- All field excursions are mandatory. If a student must miss a class, they are required to
 notify the instructor as soon as possible and no later than the start of the class. A
 justifiable reason for the absence is expected. Missing a class may result in a deduction
 from the final participation grade because the absence could cause a lack of
 contribution to data collection and/or unanticipated responsibilities of group members.

^{**}Students are expected to participate in all activities. Assessment is based on attendance, engagement, contributions to field work, equipment care, and questions asked during peer presentations.



- Excursions will proceed as planned unless there is an extreme weather warning. If the
 weather prevents us from leaving campus the schedule may be revised or an alternate
 indoor exercise may be planned.
- Students are expected to carefully use and return all field equipment.
- Field safety is of critical importance. All students are expected to behave responsibly and safely.
- If a student has any health or mobility-related issues that may affect their safety or ability to perform fieldwork, they must inform the instructor at minimum TWO weeks in advance of the first field trip for accommodations.

Course Policies on Missed or Late Academic Requirements

Late penalties: Late assignments will be subject to a late penalty of 10% per day (including weekends). Assignments submitted seven calendar days past the due date will be assigned a zero. If you require an accommodation, please speak with the instructor in advance of the due date or at most, two days after the due date has passed.

Missed Quiz or Field Excursion: Students must email the instructor prior to the quiz if they are not able to write the assessment. One lowest or missed quiz grade will be dropped. Cases will be reviewed individually to determine if a missed assessment will be replaced by (a) a make-up quiz offered on another date, (b) an alternate assignment, or (c) a re-weighting of already assessed components. Missing a field day without just cause will result in a 2% deduction from the final participation grade. The reason for this is the absence indicates no contribution to data collection or the processing of samples, and in some cases, leaves group members with additional work. Students who miss a class must still complete the assignment and speak with classmates to receive data.

Student Declaration of Absence: The Student Declaration of Absence (SDA) Form will be used for absences of three days or fewer that result in missed or late academic requirements. If necessary, the completed form should be emailed to the instructor. Submission does not provide automatic exemption from any academic requirements that were missed or late during an absence. Any alternate coursework arrangements for missed or late academic requirements are at the discretion of the instructor.

Students are encouraged to work together on data collection, but the collaborative effort must be fair, balanced, and devoid of copying from peers. All online quizzes must be written individually.



Learning Objectives

- Develop skills in visual and/or auditory identification of eastern Canadian amphibians, birds, reptiles, and trees
- Apply basic field techniques to survey wildlife, assess soil, and sample other biotic and abiotic components
- Utilize GPS and basic GIS tools to incorporate a spatial dimension into sampling activities
- Experiment with visualization techniques appropriate for environmental field data
