Course Objective: In this course, we will investigate the interactions between the environment and the economy. We will apply economic tools to analyze the causes and effects of environmental degradation of water and air in particular, and examine the different policies that have been used to improve environmental quality (with special emphasis on the U.S. in the book).

Course requirements:

Assignments (40%):

- Assignments are based on articles from Stavins, videos, or experiments.
- Assignments are due every week (almost), on Sunday by 11:59pm. You have one week to complete each assignment.
- There will be 10 assignments total. The best 8 will count toward your grade.
- All assignments are to be individual work. You may discuss with others, but the writing must be done in your own words.

- No late assignment allowed.

Presentations (8%):

- For each assignment you will complete, you will also submit (on the same date) a summary video of the assignment.
- There will be 10 presentations total. The best 8 will count toward your grade.
- In this short video, you will use one slide only, and have 5 minutes max to summarize your assignment for that week. Ideally, we should see the slide, and your face when presenting.
- Upload your video onto Brightspace (Assessments/ Presentations)
- No late presentations allowed.

Participation (7%):

- Each one of you will comment on 2 other presentations (see above). Your (written) comments should include (a) a title (the name of the student you are reviewing), (b) one specific positive comment on their presentation (i.e. avoid sweeping statements such as "great presentation"), and (c) one specific constructive criticism that they could use to improve their presentation(s) in the future.

- Your comments will be due on Monday by 11:59pm (a day after the due date of the assignment).
- There will be a total of 10 comments due (x2 each time). Only 7 will count toward your final grade.
- Upload your comments onto Brightspace (Assessments/ Comments)
- No late comment submission allowed.

Quizzes (25%):

- Short quizzes will be given at the end of every other week, on Thursday.
- Each quiz will be graded out of 5 questions.
- You will have 10 min to complete each quiz (available from 8 am to 8 pm Halifax Time).
- There will be a total of 6 quizzes. The best 5 quizzes will count toward your grade.
- Any missed quiz will earn a grade of zero.
- All quizzes are to be individual work.
- Open books are allowed.

Final Exam (20%)

- A 2 hour comprehensive exam will take place during finals week.
- The exam will be based on everything covered during the term (lecture notes and assignments).

- The exam will be scheduled by the Registrar's Office during the final exam period (April 8 - 28). Do not make travel arrangements during this period.
