# **Course Description**

Law and Economics is the study of optimal legal frameworks. Microeconomic theory will be used to study the efficiencies of property, contract, tort, criminal, and antitrust law. Further, there will be a critical analysis of the role of the Competition Bureau in Canadian markets, and the tools used to evaluate transactions on a case by case basis.

• ECON 1101: Principles of Microeconomics

## **Course Objectives/Learning Outcomes**

This course will provide a broad overview of the relationship between law and economics, as well as the basics of Canada's legal system. Students will acquire the skills to evaluate efficiencies and the basic theories of ownership, contract, tort and criminal law.

Students will also learn how the Competition Bureau operates, with a focus on the skills used to analyze proposed transactions and their potential market effects.

No prior knowledge of the law is required.

# **Course Project**

Students should seek approval for the subject of their project topic prior to February 27<sup>th</sup> via positing on the applicable Brightspace Forum. Duplicative topics will not be permitted.

The project will have the following deadlines:

- 1. Written Submission worth 60%
- 2. Presentation worth 40%

A grading scheme for the written submission will be provided at a later date.
