

APPLICATION TO EMBARGO A THESIS

- WHEN A THESIS HAS BEEN UPLOADED TO DALSPACE IT WILL NORMALLY BE INCLUDED IN THE INSTITUTIONAL REPOSITORY AND THE LIBRARY AND ARCHIVES CANADA COLLECTION UNLESS THERE IS A COMPELLING REASON FOR WITHHOLDING IT.
- APPLICATION TO EMBARGO A THESIS MUST BE SUBMITTED TO THE FACULTY OF GRADUATE STUDIES BEFORE YOUR THESIS DEFENCE.
- APPLICATION MUST BE WORD-PROCESSED AND SIGNATURES MUST BE ORIGINAL.
- ALL EMBARGOS WILL BE FOR A ONE YEAR PERIOD.
- IN CERTAIN CASES A 1 YEAR EXTENSION CAN BE REQUESTED. REQUESTS MUST BE IN WRITING TO THE FACULTY OF GRADUATE STUDIES ONE MONTH BEFORE THE EXPIRY OF THE INITIAL 1 YEAR EMBARGO. THE REQUEST MUST INCLUDE A DETAILED EXPLANATION OF THE REASON FOR THE ADDITIONAL 1 YEAR HOLD.
