Judy E. MacDonald, PhD is Professor, Director School of Social Work, Assistant Dean Equity and Inclusion, Faculty of Health, Dalhousie University. Scholarship focuses upon access and inclusion within post-secondary institutions for students with (dis)Abilities, autoethnographic and narrative storying of (dis)Ability, anti-oppressive ways of working across abilities, andaccess & accommodations. Judy has been co-chair of the CASWE Persons with Disability Caucus for eighteen years, previously on the Editorial Board of the Canadian Social Work Review journal where she served for three years as Anglophone co-editor, and she has been an invited contributor to numerous books on progressive social work and critical (dis)Ability.

Melissa Myers graduated from Dalhousie University with a Masters' in Social Work in 2013. Her social work practice experience has been based in a hospital setting, as well as with not-for-profit. Melissa is a woman with a (dis)Ability who is living with cerebral palsy. She has been a strong advocate for (dis)Ability rights and is also highly involved in researching theoretical and practical issues surrounding (dis)Ability, including policy and social work intervention. Her advocacy work led to the implementation of the Workplace Attendant Support program through the Department of Community Services, which began in September 2014. She is currently continuing her advocacy through her position as Accessibility Advisor in the Office of Diversity & Inclusion within the Halifax Regional Municipality (HRM).
