## The Schulich Fellowship 2025-2026 Call for Expressions of Interest

Schulich Fellows participate actively in the intellectual life of the Schulich School of Law at Dalhousie University in a way that supports their development as scholars and teachers. Schulich Fellows are expected to teach a course in the first year J.D. program. This year we are also interested in applicants who can contribute to our *Health Law and Social Justice* curriculum. Schulich Fellows participate in the scholarly activities of the faculty, including the faculty seminar series. It is anticipated that they will be working toward publishing parts of their graduate work and conducting new research. It is not anticipated that Fellows will carry administrative responsibilities. Fellows are expected to be in residence at the School from the beginning of August 2025 through the end of June 2026.

Applications will be adjudicated on a combination of academic record (including research productivity) and the fit between the applicant's research and teaching interests and the clusters of research and teaching at the School and the School's strategic priorities and needs. Applicants are generally expected to be doctoral students in at least their third year of their doctoral studies.

This is an 11-month, part-time academic appointment. Fellows receive a total stipend of \$55,000.
