ABOUT US

As the health care realm forges ahead with advances and discoveries, legal and ethical questions abound. The Dalhousie Health Law Institute, which is supported by and works with the Faculties of Law, Medicine, Health, and Dentistry at Dalhousie University, responds to these questions.

The Health Law Institute is the national leader in health law and policy research in Canada. We are among a small number of academic institutions with international impact in this field.

Our Institute faculty are regular policy consultants to government bodies, public interest groups, the private sector, and health care organizations.

We offer the first and only health law and policy specialization for JD students in Canada, and we welcome graduate students from across the country and around the globe.

LEADING INTERDISCIPLINARY SETTING

For over two decades, we have taken the lead in attracting and fostering a new generation of students trained in health law.

Our faculty teach at the undergraduate, graduate, and continuing education levels, and we supervise students interested in writing about topics at the intersection of law, health care, policy, and ethics. While our course offerings and mentoring activities are primarily located within the Schulich School of Law, we also supported the development and delivery of a health law curriculum for students within the Faculties of Medicine, Dentistry, and Health Professions.

RENOWNED RESEARCH ON TOUGH ISSUES

Our Institute is widely recognized for the quality and impact of our research. Our members have received numerous grants, awards, and research contracts and pursue research in challenging areas such as:

EXTENSIVE COURSE OFFERINGS

Our Health Law and Policy Program is the largest course offering of its kind in Canada, and leads to a JD specialization in Health Law and Policy. Our Program prepares graduates to excel in one of the fastest growing areas of practice. Some of our course offerings include:

To earn the Health Law and Policy specialization, students must take Health Law and three additional elective classes in the upper years of the JD program. Students interested in registering for the Health Law and Policy Specialization should contact the Director of the program as early as possible and ideally at the start of second year.

COMMITTED PUBLIC SERVICE

As a resource for both the University and the broader community, the Institute is committed to public service. We regularly provide background information and give interviews to the media. We offer consultation services to various government agencies as well as public interest groups, the private sector, and health care institutions. We speak at a wide variety of meetings, serve on local, provincial, and national committees, and respond to requests for information from the general public. Our Health Law Students' Association is active in the student community and runs a wide range of activities connected with health law and policy.

We also host an extremely popular health law and policy seminar series that is open to the public, and attracts a broad audience from across the university and health care communities. Our eight speakers per year are all nationally or internationally recognized experts in their field, and each lecture spotlights a current area of legal and ethical controversy.
