

Career Advance MBA Pathway International Applicant Declaration

International applicants interested in the Career Advance MBA Pathway must read the following document, sign and date at the bottom, and submit it to mba@dal.ca as part of their application.

Program considerations:

- 1. This program is offered as a Part-Time Online/Blended model and is not an on-campus program. This program cannot be completed on a full-time basis.**
 - This program is not eligible for a post-graduation work permit, because it is a part-time program.
 - International students are not eligible to work in Canada (either on or off campus) while taking this program.
 - You will need to provide proof of a valid study visa before starting the program.
- 2. Courses are delivered live and online (synchronous) and take place primarily between 6:00PM and 10:00PM AST (Atlantic Time).**
 - Most students in the program reside in Canada. Group work makes up a significant part of the curriculum and most team meetings with your peers take place in the evening and across various Canadian time zones.
- 3. Most core courses have in-person 3.5-day intensives, which all students registered in the course must attend. Intensive sessions are held at various locations across Canada (e.g. Vancouver, Calgary, Toronto, Halifax). Not attending an intensive will result in an academic penalty, which could lead to a failed grade for the course.**
 - Arranging travel visas, booking travel, accommodations for intensives, living arrangements during the program, and all associated costs are your responsibility.
- 4. Not all courses are offered every term and intensives are not offered in every city. You may need to wait for the next term to take a course to complete your program.**

Financial considerations:

- 1. International students pay an additional [international differential fee per course](#). This fee must be paid along with tuition upon registration for the course. Tuition and international differential fees are subject to an increase each year.**
 - There are no waivers for the application fee, admission deposit, per-course tuition fee, per-course international differential fee, textbook or course material fees.
 - As a part-time student at Dalhousie there is no access to some of Dalhousie's services (e.g. no gym access, no student bus pass).
 - As part of your application, you will be required to provide a letter of financial guarantee and proof of funds showing that you have access to \$70,000 CAD to cover

all associated fees, tuition, travel, accommodation and living costs. Accepted proof of funds documents are bank statements or certificates of deposit.

- *All applicants are required to pay a non-refundable application fee.*
- *If you are accepted into the program, a non-refundable admission deposit will be required to hold your seat in the program.*

Additional Considerations:

- *It is your responsibility to apply for the necessary study visas, extensions etc. in a timely manner, especially before your visa expires, to continue in the program. For assistance with the visa application process, please contact the International Centre, international.centre@dal.ca*
