



## **Canada Research Chair in Reconciliation, Gender and Identity**

The Faculty of Arts and Social Sciences at Dalhousie University invites applications for a Tier 2 Canada Research Chair (CRC) in Reconciliation, Gender and Identity, with a tenure-stream appointment at the rank of Assistant Professor. The position is open with regard to disciplinary specialization, with a primary appointment in one of the Faculty's 11 Departments.

The successful candidate must have a PhD and an outstanding research profile for their career stage with an innovative and original research programme. They should be an emerging leader in advancing research on Reconciliation looking at both Indigenous and Settler experiences. The candidate should also be able to demonstrate an ability to work with community and to engage issues of decolonizing the university and translating Indigenous and non-Indigenous knowledge systems across stakeholders. In light of the national inquiry into Murdered and Missing Indigenous Women and Girls, the ability to engage the role of gender in the formation of identity will be a core focus of the position, with a special emphasis on intersectionality and the experience of Two-Spirited and other identities.

The holder of the Chair will be expected to enhance the university's commitment to community development and its relationship with government and service provider organizations and the non-governmental sector. They will also be encouraged to make connections with cross-faculty initiatives at the university and coordinate projects across academic and non-academic sectors to build successful partnerships and pursue external funding to support them. The successful candidate will have a strong track-record of obtaining external funding; they should also have a demonstrated ability to work co-operatively and can provide leadership in an interdisciplinary environment, develop multi-faceted research projects, and work with graduate students and/or post-doctoral fellows.

Located in the heart of Halifax, Nova Scotia, with an Agricultural Campus in Truro/Bible Hill, Dalhousie is a truly national and international university, with more than half of our 18,500 students coming from outside of the province. The CRC program was established by the Canadian Federal Government with the purpose of attracting outstanding researchers to the Canadian university system. Tier 2 Chairs are intended for exceptional emerging scholars (i.e. the candidate must have been an active researcher in their field for fewer than 10 years at the time of nomination). Applicants who are more than 10 years from their highest degree (and where career breaks exist, including maternity leave, extended sick leave, etc.) may have their eligibility for a CRC Tier 2 assessed through the program's Tier 2 justification process. Dalhousie recognizes that career paths can be diverse and that career interruptions may occur. Applicants are encouraged to include, in their cover letter, an explanation of the impact that any career interruptions may have had on their record of research achievement.

Dalhousie University is committed to fostering a collegial culture grounded in diversity and inclusiveness. In keeping with the principles of employment equity and the CRC program's equity targets, this position is restricted to candidates who self-identify as Indigenous. Dalhousie recognizes that candidates may self-identify in more than one equity-seeking group, and in this spirit, encourages applicants who also identify as women, racially visible persons, persons with a disability, or persons of minority sexual orientations or gender identities.
