Canada Research Chair Tier 2 in Indigenous Governance**

The Faculty of Management and the Schulich School of Law, Dalhousie University, invite applications for a Canada Research Chair in Indigenous Governance (probationary tenure-track, tenure-track or tenured), Tier 2, at the rank of Assistant, Associate or Full Professor.

We welcome candidates, both national and international, with scholarly expertise in the broad field of Indigenous Governance. Scholars working in this field may be pursuing research in any number of areas, such as: Indigenous self-determination and intergovernmental relations (at the local, national and/or international level); natural resource management, economic development, and Indigenous environmental justice; innovation, entrepreneurship, and Indigenous governance; energy policy, dispute resolution, and Indigenous legal orders; Indigenous feminism, rights and regulatory frameworks; or social, economic, and cultural security and resurgence.

The CRC program was established by the Canadian Federal Government with the purpose of attracting outstanding researchers to the Canadian university system. Tier 2 Chairs are intended for exceptional emerging scholars (i.e. the candidate must have been an active researcher in their field for fewer than 10 years at the time of nomination). Applicants who are more than 10 years from their highest degree (and where career breaks exist, including maternity leave, extended sick leave, etc.) may have their eligibility for a CRC Tier 2 assessed through the program's [Tier 2 justification process](#). Please contact the research grants office and see the CRC website (www.chairs.gc.ca) for more information on eligibility.

Candidates should propose an original, innovative research program of high quality, that aligns with Dalhousie's Research and Innovation Strategic Research Direction Information on Dalhousie's strategic research plan is available at <https://www.dal.ca/research/SignatureResearchClusters.html>.

The Schulich School of Law and the Faculty of Management are committed to deepening our identities as diverse and inclusive faculties, building upon such efforts as the Indigenous Blacks & Mi'kmaq Initiative and the Chancellor's Chair in Aboriginal Law and Policy. Dalhousie University is committed to fostering a collegial culture grounded in diversity and inclusiveness. In keeping with the principles of employment equity and the CRC program's equity targets, as well as the nature of this position, **this position is restricted to candidates who self-identify as Indigenous or Aboriginal persons.** (See www.dal.ca/becounted/selfid for a definition of this group.) Dalhousie recognizes that candidates may self-identify in more than one equity-seeking group, and in this spirit, encourages applicants who also identify as persons with a disability, racially visible persons, women, or persons of minority sexual orientations or gender identities.

The Faculties of Management and Law will jointly provide the hub and the support for the CRC program of research in Indigenous Governance and for increased interdisciplinary research collaborations between the Schulich School of Law and the Faculty of Management and with other researchers.

Applicants should have an outstanding academic record, a record of scholarly engagement, and demonstrated (or potential) teaching excellence. At the time of appointment, the successful candidate will have a graduate degree in Law (completed or in progress), or a doctoral degree in Management or a related discipline.

Dalhousie recognizes that career paths can be diverse and that career interruptions may occur. Applicants are encouraged to include, in their cover letter, an explanation of the impact that any career interruptions may have had on their record of research achievement.

Review of applications will begin on July 1, 2019, and continue until the position is filled. To guarantee consideration of your application, please apply by July 1.

Applications should include a CV, university transcripts, a maximum 7-page teaching and research statement, the names of three referees, at least one of whom must be an academic referee, and a completed Self-Identification Questionnaire, which is available at www.dal.ca/becounted/selfid.
