

APPLICATIONS NOW OPEN

The Canadian Science Policy Centre (CSPC) and the Office of the Chief Science Advisor (OCSA) are pleased to accept the applications for the fourth iteration of the program: Science Meets Parliament 2024!

The program includes several training zoom sessions over winter and spring, and two days of events in Ottawa on May 6-7, 2024.

OBJECTIVES

The objective of this initiative is to strengthen the connections between Canada's scientific and political communities, enable a two-way dialogue, and participate in policy development initiatives. This initiative aims to help scientists become familiar with policy making at the political level, and for parliamentarians to explore using scientific evidence in policy making, enable two-way dialogue, and promote mutual understanding. The program is NOT an advocacy exercise for science or for the scientific community.

This will be the fourth Canadian Science Meets Parliament. Over 110 emerging leaders in the scientific community have benefitted from the policy and communications skills developed through Science Meets Parliament.

SCIENCE MEETS PARLIAMENT

ELIGIBILITY

The program will be available to three streams:

- Researchers who currently hold a Tier II Canada Research Chair position and are affiliated with a Canadian post-secondary institution (Tier II Canada Research Chair status must be announced by October 11th, 2023).
- Indigenous Principal Investigators (priority will be given to researchers who are independent investigators affiliated with academic research institutions).
- Researchers who currently hold a Banting Postdoctoral Fellowship and are affiliated with a Canadian post-secondary institution (Banting Postdoctoral Fellowship status must be announced by October 11th, 2023).

Meetings with members of Parliament, senators, and the Chief Science Advisor of Canada.







