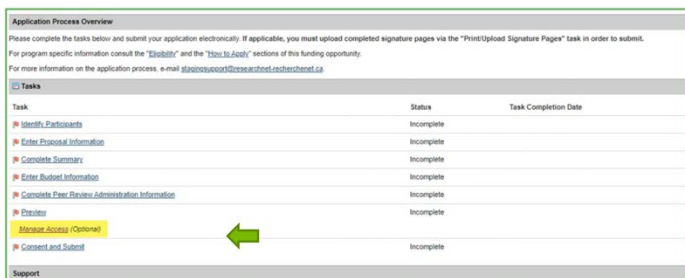

Priority E: Integrate Evidence in Health Decisions

- E.3.3 Enhance Canada's capacity to fund, conduct and use clinical trials by strengthening highly qualified personnel, clinical trials environments and research investments



What we heard about development of a long-term clinical trials strategy

Looking ahead to the development of a sustainable and long-term clinical trials strategy, CIHR sought feedback on what key elements should be included and several themes emerged:

- Integration of clinical trials within the health care system with infrastructure support for clinical trial programs and highly qualified personnel
- **National coordination of clinical trial start-up activities (ethics, contracts), data sharing mechanisms, and research transparency (standardized application templates, minimal consent guidelines, agreement templates etc.)**
- Enabling the inclusion of all Canadians in clinical research
- Importance of meaningful patient engagement when establishing research priorities and developing clinical trial protocols so that the outcome of the research meets the needs of patients
- Leadership in clinical trials at a national and international level
- Building long-term funding streams with predictable cycles of grant calls and sufficient time to develop strong applications
- Increasing the capacity of highly qualified personnel to perform clinical trials by providing training programs in trial design and biostatistics, regulatory compliance, quality assurance and clinical research administration

4. The University Delegates discussed the need for increased funding for all CIHR programs.

The University delegates discussed the need for investment in health research in Canada. Each University Delegate has been asked to communicate to the local community how we can collectively urge the federal government to consider increasing CIHR budgets to be closer to levels for other G20 countries. MRDO will be communicating an opportunity for people who want express their support for investment in health research as a critical part of Canada's health and economic wellness to Members of Parliament, Ministers and Senators.
