## Innovation Fund (IF) 2020 Objectives:

- 1. Enable global leadership by supporting worldclass research or technology development.
- 2. Enhance and optimize the capacity of institutions and research communities to conduct the proposed research or technology development program(s).
- 3. Lead to social, health, environmental and/or economic benefits for Canadians.





## **Objective 1:**

- Research or technology development: The research or technology development program(s) are innovative, feasible and internationally competitive.
- **Team:** The diverse team comprises the breadth of expertise to conduct the proposed program(s).





## **Objective 2:**

- Research capacity: The institutions and their partners have the necessary research capacity on which this proposal will build.
- Infrastructure: The requested infrastructure is necessary and appropriate to conduct the proposed program(s).
- Sustainability: The infrastructure will be optimally used, operated and sustained over its useful life through tangible commitments.





## **Objective 3:**

**Benefits**: The team and its partners have a well–defined plan to transfer the results of the research or technology development program(s). The results are likely to lead to social, health, environmental and/or economic benefits for Canadians.





## Budget

- CFI will provide up to 40% of the total project costs
- Remaining 60%:
  - In-kind contributions from vendors
  - Eligible cash contributions
  - Application to Research Nova Scotia

It is the responsibility of the researcher to ensure the budget is balanced prior to submission of the application


## **2020 IF Results**

- 307 proposals received, requesting a total of \$1.1B from CFI
- 102 proposals approved for \$400M funding from CFI
- Dalhousie Results:
  - Administrative Lead 5 proposals, >\$12M (Dal Total)
  - Partnered 3 proposals, \$1.24M
  - Total Dal CFI funding: >\$13M

## **Scoring System**

- Exceeds
- Fully Satisfies
- Satisfies
- Partially Satisfies
- Does not Satisfy



In general, to be successful, you must score Exceeds or Fully Satisfies across all criteria and objectives.



# What's Required for a Successful Application?

• World-class team

- SUCCESS
- Cutting-edge and globally-competitive research
  program
- Defined pathway to realize benefits for Canadians



## **Common weaknesses:**



- Research or Technology Development
  - Lack of details on activities
  - Feasibility of the approach or methodology
  - Lack of focus, too broad or ambitious, not integrated, not innovative
- Team
  - Missing expertise, lacking critical mass of experts
  - Track record as a team

#### Research Capacity

Lack of cohesion with the proposed research area



Common weaknesses (con't):

#### Infrastructure

- Not well justified, wrong equipment, not linked to the research program
- Lack of details on existing or similar infrastructure available elsewhere

#### Sustainability

- Insufficient infrastructure, access or data management plan
- Lack of details for costs/revenues, underestimated costs, insufficient revenues


#### Benefits

- Pathways not well defined
- Overstated or weak benefits





#### Success and funding rates by funding request





## **IF Internal Application Process**



- CFI allocates an Institutional Envelope
  - Dal envelope for 2020 IF: \$27.1M
- Internal call to Faculties for Expressions of Interest
  - Faculties rank order proposals
  - Committee, led by VPRI, reviews proposals
  - Additional details may be requested, in particular for larger proposals







## **Application Development**

- 1. Notice of Intent:
  - 5 pages, no CVs, budget total
- 2. Full application:
  - Assessment Criteria (30-35 pages)
  - Project Summary (3 pages)
  - CVs for 10 Team Members
  - Detailed budget and renovation plans (if applicable)
- Guidance, oversight and review provided by ORS,
  Institutional and International Programs
- Additional support available upon request
- Internal deadline for complete draft (including final budget) 6-8 weeks prior to CFI deadline



## What can you do now to prepare?

- Anticipate your needs and talk to your Dean/ADR
  - space and/or renovations, matching funds, teaching release or support during application development
- Build your team of researchers
  - Consider the principles of EDI in building your team
  - Include a mix of early, mid-career and senior researchers
  - Think beyond your Department/Faculty/Institution
- Meet monthly to discuss research proposal ideas
- Think forward to potential benefits for Canadians, alignment with RNS Missions and end-users
  - Reach out to OCIE about industry partnerships
  - Connect with government and/or community groups

What not to do	Instead
Do not create an "equipment wish list"	Develop a cohesive research program that requires the requested equipment
Do not build a team based on shared use of the infrastructure	Bring together researchers with the necessary expertise to accomplish the research goals
Do not wait to contact potential research end-users	Develop a realistic plan to transfer knowledge to end- users
Do not underestimate the time required to prepare a competitive IF application	Start discussions early and develop draft documents and budgets
