

Codes of Practice

"Researchers have an obligation to become informed about, and to respect, the relevant customs and codes of research practice that apply in the particular community or communities affected by their research."

TCPS. 9.8

Key Aspects in Indigenous Research - Chapter 9 Summarized

Research Agreements

 Where a community has formally engaged with a researcher or research team through a designated representative, the terms and undertakings of both the researcher and the community should be set out in a research agreement before participants are recruited. TCPS 9.11

Collaborative Research

 As part of the community engagement process, researchers and communities should consider applying a collaborative and participatory approach as appropriate to the nature of the research, and the level of ongoing engagement desired by the community. TCPS 9.12

Summary cont.

Mutual Benefits in Research

- Research should be relevant to community needs and priorities.
- Benefit the participating community (e.g., training, local hiring, recognition of contributors, return of results).
- Extend the boundaries of knowledge. TCPS 9.13

Strengthening Research Capacity

 Projects should support capacity building through enhancement of the skills of community personnel in research methods, project management, and ethical review and oversight. TCPS 9.14

Recognition of the Role of Elders and Other Knowledge Holders

- Researchers should engage the community in identifying Elders or other recognized knowledge holders to participate in the design and execution of research, and the interpretation of findings in the context of cultural norms and traditional knowledge
- Community advice should also be sought to determine appropriate recognition for the unique advisory role fulfilled by these persons. TCPS 9.15

b) Recruitment criteria that include Indigenous identity as a factor for the entire study or for a subgroup in the study







d) Indigenous identity or membership in an Indigenous community is used as a variable for the purpose of analysis of the research data

c) Research seeks input from participants regarding a community's cultural heritage, artefacts, traditional knowledge or unique characteristics







e) Interpretation of research results that will refer to Indigenous communities, peoples, language, history or culture (primary and secondary data).


Data Analysis and Interpretation



 Researchers should afford community representatives engaged in collaborative research an opportunity to participate in the interpretation of the data and the review of research findings before the completion of the final report, and before finalizing all relevant publications resulting from the research. TCPS 9.17

Data Sovereignty and Intellectual Property

 In collaborative research, intellectual property rights should be discussed by researchers, communities and institutions. The assignment of rights, or the grant of licenses and interests in material that may flow from the research, should be specified in a research agreement (as appropriate) before the research is conducted. TCPS 9.18



TCPS 9.10 Community Engagement Documentation - Where Research Ethics is concerned at Dalhousie, a Collaborative Research Agreement must accompany an REB proposal. Where there are other types of Indigenous Research, an agreement or other types of documentation would be expected to accompany a proposal.

Agreement

A preliminary or formal research agreement between the researcher and the responsible body at the research site.

Decision

A written decision or documentation of an oral decision made in a group setting to approve the proposed research or to decline further participation.

Summary

A written summary of advice received from a culturally informed advisory group or ad hoc committee (e.g., an urban community of interest).

Letter

Where a researcher has an ongoing relationship with a community, a letter from formal or customary leaders in the relevant community may signal approval.

Rationale

Where community engagement is not being proposed, researchers shall provide a rationale acceptable to the REB., e.g., participants are not identified with a community or that the welfare of relevant communities is not affected.

More than a Checklist

Position

- ✓ The researcher described their motivation for undertaking the project.
- ✓ The project objectives demonstrate alignment with community priorities.
- ✓ Indigenous partners are considered equal.

Support

- ✓ There is clear evidence of Indigenous community support.
- Community
 is involved
 at every
 stage of the
 research.

Paradigm

✓ The epistemology, axiology, methodology and ontology reflect Indigenous worldviews and values.

Budget

- ✓ Community partners' and, contributors' time and expenses are appropriately acknowledged and accounted for.
- ✓ Budget includes allocations for community gatherings and/or other types of cultural protocols.

Sharing

- Community partners are involved in data analysis and interpretation.
- ✓ Data management, intellectual property and knowledge mobilization plans include cultural considerations and respect for protocols
