All information collected will be kept strictly confidential, stored in a secured server, and used to produce statistical summaries only. Any directly identifying information (name, address) will be stripped at the beginning of data processing and replaced by anonymous codes. DalTRAC researchers will have access to the datasets for use in research projects and to help inform transportation planning decisions.

Participation in the survey is **entirely voluntary**. There is no direct personal benefit to the survey participants. The risks associated with this research are minimal, with no direct risk to participants. Respondents will be able to withdraw from the survey at any time until final submission. You are welcome to refuse answering questions if you no longer want to participate. Incomplete surveys will not be used for further analysis. After submitting the survey, you will have the option to withdraw your data within two weeks (please contact DalTRAC Project Coordinator-Email: daltrac@dal.ca). If you withdraw from the survey, you will still be eligible to receive entry into the draw. The anonymized dataset will be kept for 10-25 years, depending on research needs.
