Teaching and Mentorship Activities

Teaching Philosophy (In short)

It is not education, but education of a certain kind, that will save us —David Orr, Earth in Mind (2004)

As a result of a wide variety of teaching experiences, I have come to understand how exciting, fascinating and rewarding it is to teach. Postsecondary education is a process of growth from dependence to both independence and interdependence and it is my responsibility to facilitate this development.

I believe that my role is to help students grow by challenging their own constructs (personal knowledge) and those that society presently adheres to (public knowledge) and to provide students with opportunities to learn for themselves (independent learning) and with others (interdependent learning). My role as a teacher is that of a guide and facilitator. I often remind students of the power they have over their own learning. It is for this reason that I work with students to develop course syllabi together, and create assignments that are meaningful to individual students and to the class.

I recognize that students have many and varied learning styles and realize that these must be identified at the beginning of each course. I understand the need to respond to differences in learning styles by creating multiple paths of investigation for individuals and groups of students as well as leave room for students' ideas, questions and needs. Additionally, I view all post secondary students as adults, and therefore adhere to many of the assumptions of the andragogical model (Knowles, 1980) including: adults have a self-concept as being self-directed learners; adults have numerous and varied experiences that can be shared with colleagues; adults see a clear purpose for learning; and adults prefer problem and task-centred learning.

Experiential learning theory is paramount to my teaching philosophy. Experiential learning, or learning through action and reflection, creates a connection between the learner and the content being taught. This idea of promoting meaningful connections underpins the many strategies I use such as concept maps, class discussions, practical group work assignments, experiments, games, and often field trips.

I am a firm believer in developing meaningful relationships with students. I am therefore dedicated to being available to students to help them in their learning in any way possible. In the past, this has meant assisting students in the preparation of graduate school applications, discussing personal problems as well as helping develop personal goals for the future. I have found that this makes the teacher/student relationship richer.

Finally, as students grow and develop, I believe that I must too. I am dedicated to improving my teaching skills, learning and developing new methods for effective teaching, and reflecting on my experiences. This is facilitated through attending teaching workshops, administering formative and summative evaluations in all of my classes, reading articles on teaching efficacy, and keeping a personal journal of my instructional activities. Teaching is a pleasure for me, and I feel that self-reflection and the desire to improve will make the activity even more joyous in the future.

Selected Highlights of Administrative Work

I began my career at Dalhousie as an academic administrator. I was hired in 2001 as the first Director of Environmental Programs for the Faculty of Science at Dalhousie University. My initial responsibilities as Director included the administration of the unit: its programs (at that point a Minor in Environmental Studies), staff and faculty; preparing budgets, allocating teaching assignments, teaching in the program, service to the Faculty of Science Executive Committees, and developing a full major program in Environmental Science. With the enthusiastic and capable support of the Dean, I collaboratively developed and launched the B.Sc. in Environmental Science in 2003, a program that enjoys increased enrolment almost every year since its inception. In my position as Director, I liaised with various departments, faculties, universities and environmental agencies and companies in Halifax with interests in environmental fields which resulted in the development of collaborative relationships and official Minors in Environmental Studies with the Faculty of Architecture and Planning, Faculty of Engineering, Faculty of Computer Science, Kings College, and Faculty of Arts and a double Major in the College of Sustainability. Working closely with community stakeholders such as Stantech, Ecology Action Centre, Clean Nova Scotia Foundation, World Wildlife Fund, Environment Canada, CBCL, and the Bedford Institute of Oceanography, I developed an Internship Program in Environmental Science to help students get hands-on job experience while applying the skills they have learned in their undergraduate courses. I raised the profile of Environmental Science at Dalhousie University through the development of an national advertisement campaign (and a collaboration with a 4th year NSCAD design course), and by representing Environmental Science on various provincial and national committees including the National Environmental Science Directors Committee, and the Atlantic Provinces Council on the Sciences Environmental Studies Committee (now Science Atlantic).

Upon returning from a parental leave in August 2008, I stepped into the role of Associate Director (Undergraduate) in the burgeoning College of Sustainability where I played a pivotal role in the development of the College governance structure, and the development of the Environment, Sustainability and Society (ESS) undergraduate program. I was deeply involved in the original conceptualization of the College for three years before it became a reality within the university. During my time as Associate Director, I worked collaboratively with colleagues throughout the university and provided general oversight and leadership for the ESS program. I also led a consultative process amongst core faculty to develop consensus on the knowledge, concepts, dispositions, and skills that ESS students should acquire through the program. This process involved conducting a Delphi study that began with 188 participants from academia, the not-for-profit sector and relevant government departments/agencies, and concluded in 59 areas that were ranked as highly important for inclusion in the ESS curriculum, and that could then be evaluated annually in the review of the ESS program.¹

Since stepping back from my Associate Director role at the College of Sustainability, and returning to the Faculty of Science, I have continued to use my administrative skills with the goal of serving our scholarly community. I have chaired numerous internal and external committees and have served on the University Senate. I am currently the Environmental Science Program Coordinator in the newly formed Department of Earth and Environmental Sciences and continue to act as the Co-Op and Internship Coordinator for both the Earth Science and Environmental Science programs. Finally, in 2019 I was appointed as the Dalhousie University Coordinator for the Queen Elizabeth Program which allows for the professional development and exchange of ideas amongst young people from Dalhousie University, Cape Eleuthera Institute, and the University of the Bahamas with a focus on environmental sustainability. I work closely with both the university's International Centre, and Universities Canada in managing the program for the university.
